WINTER'S FIRST BIG SNOW STORM ARRIVES HERE


Our first big snow storm of the season arrived in this area Monday, Nov. 29, dumping from four to six inches of the stuff and piling up drifts late Monday afternoon.

> The beautiful new church was completed in just over a year from first ground-breaking in November, 1970. Rev. Edwin Schmelzer is pastor of the Broom field Church as well as the Remus Lutheran Church. He will deliver the morning sermon of dedication, with Pastor C.H. Schmelzer as liturgist. In the afternoon, Pastor Howard Henke, visiting elder of the Northern Conference of the Michigan District, will deliver the sermon. The Michigan Lutheran Seminary Choir will sing at the afternoon dedication service.

The new Broomfield church is unique in architecture, with its arched beams and wood-finished walls in the worship area. The lectern at left, and pulpit at the right, are of white marble, donated by a member of the church.



#### **Legal Notice**

In order to establish a zoning district in the Public interest governing the unincorporated portion of Sherman Township, Isabella County, State of Michigan, according to the provisions of Act 184, of the Public Acts of Michigan of 1943:

TITLE: ESTABLISHING A LIMIT-ED ZONING ORDINANCE OF SHERMAN TOWNSHIP.

Article I

District of zoning maps established as:

A--Agriculture. B--Lake Resort.

N. I. -- Neighborhood Business District.

R--Rural Residence. P--Park and Recreation.

CH--Church. C--Cemetery.

G.P. -- Gravel Pits.

S.F. -- School Forest

H--Hall. Article II

General provisions.

Section A. Scope

1. Except as otherwise provided in the ordinance, the lawful use of any parcel of land, building or structure existing at the time of enactment of this ordinance, although such does not conform with the provisions

thereof, may be continued. 2. Beginning with the effective date of this ordinance, no new buildings, or structure or part thereof, shall be located, erected or used for purpose other than in conformity with the provisions

of this ordinance.

3. Junk yards and any use which presents a nuisance, are expressly prohibited. All junk yards shall be 200' from the roadway and have 6' solid fencing. The above must be approved by the zoning board.

4. All outdoor toilets are subject to health department approv-

al.

Section B.

Non conforming land, building and structure.

1. If the non conforming use of any parcel of land, building, or structure is discontinued for a continuous period of six (6) months or more, then any future use of such building, structure or land shall conform to the provisions of this ordinance.

2. Whenever the non conforming use of any building, structure or parcel of land has been changed to a conforming use, the use of same shall not thereafter be reverted to any non-

conforming use.

Section C. Sewage disposal systems.

1. Water and sewage disposal systems must meet State and County Health stipulations.

Section D. Mobile Homes.

1. Mobile Homes must be properly skirted and anchored at least | a septic tank type of sewage dis-30" deep. Mobile homes must

have a building permit. Article III

Zoning districts and the boundaries thereof shown on the Sherman Township zoning map are hereby established, and said map and the notations, references and other information shown thereon, shall be as much a part of this ordinance as if the information set forth on such map were fully described therein. Article IV

Residential. Section A.

Uses Permitted:

In a residential district no building, structure or land shall be used and no building or structure shall hereafter be erected, altered or moved unless otherwise provided in this ordinance, except for one or more of the following

1. Residences, including home

occupations.

2. Churches, schools, publicly owned buildings, public and private hospitals, convalescent homes, community clubs, country clubs, fraternal lodges, and similar civic or social organizations when not operated as a com mercial enterprise, land for parks, picnic groves, golf courses and similar facilities for outdoor exercise recreations.

3. Apartment houses.

4. Boarding and lodging houses, and tourist homes.

5. Commercial uses will be permitted only upon application to, and approval of, zoning

Section B.

Size of lot or parcel of land.

1. Each lot upon which any single family dwelling or mobile home shall hereafter be erected, altered or moved, shall have a minimum width of 65 feet at the building line and a minimum area of 12,000 feet.

2. The County Health Department may require larger size lots, either area and/or minimum width, to provide for the proper installation of on-site sewage disposal systems.

Section C.

Setback from highways.

1. Any dwelling hereafter erect ed, altered or moved shall be set back not less than Twenty (20) feet from highway right of way line. Section D.

Side Yards.

1. There shall be side yards of not less than ten (10) feet, or not less than ten (10) percent of the lot width, where the lot is less than 100' wide. In the case of buildings or structures used for public assembly, there shall be a side yard on each side of not less than twenty-five (25) feet.

Section E. Sewage Disposal.

Sewage disposal in a residential district shall be by means of posal system installed in accord-

ance with recommendations of Isabella County Health Department.

Article V Commercial

Section A.

Uses permitted.

Any land, building or structure in a commercial district, may be used for any commercial enterprise that does not present a nuisance per se. Junk yards, or trailer coach parks, will be permitted only upon application to and approval of zoning board. Section C.

Parking Space.

Any land, building or structure used for commercial enterprise shall provide a minimum amount of off highway parking space appropriate to that enterprise. Article VI

Agriculture Section A.

Uses Permitted.

All uses permitted in the residential district shall also be permitted in the agricultural district, subject to the same terms and conditions. All land in the agricultural district may be used for any agricultural purpose. All buildings and structures erected, altered, or moved in the agricultural district for the purpose of housing, sheltering, or raising animals or poultry, shall be a minimum distance of two hundred (200) feet from any dwelling or structure, other than those of the owner of said buildings or structures.

Section B.

Non-farm Dwellings.

Non-farm homes in the agricultural district are subject to the same terms and conditions of dwellings in the residential district. Article VII

Lake Resort.

1. All building and use restrictions must be approved by the zoning board and the township board.

2. Each lot shall have a minimum width of 65.0 feet at the building line and a minimum area of 12,000 feet.

3. The County Health Departmay require larger size lots, either area and/or minimum width, to provide for the proper installation of on site sewage disposal systems.

4. No obnoxious or offensive activity shall be carried on upon any lot, nor shall anything be done thereon which may be, or may become, an annoyance or nuisance to the neighborhood.

5. All structures shall be completed on the exterior within six (6) months from start of construction, including one coat of paint or varnish on any exterior wood surface.

6. No individual sewage disposal system shall be permitted on any lot unless such system is designed, located and constructed in accordance with the requirements of the State and County Health Departments.

Article VIII

Administration.

1. The provisions of this ordinance shall be administered by the Township board, and shall be compensated as said board shall determine.

2. It shall be unlawful to build or to make outside alterations or additions, or additions to existing buildings in excess of one thousand dollars (\$1,000.00) without a building permit. Building permits will be issued by the Building Inspector within one (1) week after receipt of applications, if such permit is refused, he shall state such refusal in writing with cause.

3. Cost of building permit shall not exceed five dollars (\$5.00), regardless of cost of proposed building or improvement.

4. The cost of all petitions for rezoning shall rest with the petitioner. Cost of same shall be fifteen dollars (\$15.00). Article IX

Enforcement Section A. Enforcing Officer.

The provisions of this ordinance shall be enforced by the building inspector, chosen according to the Township Rural zoning Act 184, of 1943.

Section B.

Article X

Violations and Penalties Any building or structure hereafter erected, altered or moved, or any use of land which is begun or changed not to conform with this ordinance is hereby considered to be in violation of this ordinance. Penalty for violation shall be a fine of not less than twentyfive dollars (\$25.00) nor more than one hundred dollars (\$100.00), or imprisonment for not to exceed thirty (30) days, or both such fine and imprisonment.

Zoning Board of Appeals.

There is hereby created a Zoning Board of Appeals which shall perform its duties and exercise its powers and jurisdiction as provided by Act No. 184 of the Public Acts of Michigan, 1943, as amended, and by certain provisions of this ordinance, to the end that the objectives of this ordinance are observed, and substantial justice done. The member ship of the board shall be as provided by this Act. In the event the board fails to reach a decision on any matter, the persons affected shall have a right of appeal to the Circuit Court on questions of law and fact. Article XI

Amendments

Amendments or supplements to this ordinance may be initiated by the township board upon its own motion, by the Township Zoning Board, or may be proposed for consideration by petition of owners of real estate within one thousand (1,000) feet of any part of premises to be affected. Such petition shall be signed by

not less than sixty (60) percent of property owners within the first five hundred (500) foot area; thirty (30) percent within the five hundred (500) foot to seven hundred fifty (750) foot area; and twenty (20) percent within the seven hundred fifty (750) foot to one thousand (1,000) foot area. Each proposal not originated by the Township Zoning Board must be submitted to said board for its consideration and advice. Following such consideration, the proposal, including any changes thereto which the board deems advisable, shall be submitted to at least one (1) public hearing as provided by Section 9, Act 184, Public Acts of Michigan, 1943. The proposal shall be submitted to the County co-ordinating zoning committee for consideration and recommendation. The proposal shall be submitted to the Township Board and acted upon by said board in accordance with the provisions of Section 11, Act 134, Public Acts of Michigan, 1943 as amended and Act 191, Public Acts of Michigan, 1939. Article XII

Validity.

This ordinance and the various parts, sections, sub-sections, sentences, phrases and clauses thereof, are hereby declared to be severable. If any part, sentence, paragraph, section, sub-section, phrase or clause is adjudged unconstitutional or invalid, it is hereby provided that the remainder of this ordinance shall not be affected thereby.

Article XIII

Effective Date.

This ordinance shall be published in the Weidman Messenger, a newspaper circulating within Sherman Township, once within ten (10) days from adoption hereof. This ordinance shall become effective thirty (30) days after the date of publication thereof.
