The School Board meets in the Board Room of the new five-million-dollar high school down near Remus.

The public is notified it must drive down there, sit through five and a half hours of Board action or inaction, and drive back home after 1.30 in the morning.

We have a suggestion for the School Board:


All members of the Board are successful business or professional men. All are free on Saturday afternoons.

Pardon us, but "the people" are the taxpayers who cough up the money to build and run the farflung Chippewa Hills School District.

BIG WHEELS USED IN LUMBERING DAYS OF MICHIGAN. You have to stand beneath the great Hartwick Pines to understand what this area once was. Isabella County, along with all of the Mitten of Michigan and across the Straits and on into Wisconsin and Minnesota, were stripped of the virgin white pine by lumber men from Maine, after the Maine forests had been "cleaned out". The migration of timber men and Maine lumberjacks began as early as 1836, when Charles Merrill of Lincoln, Maine, bought a vast block of timber on the St. Clair River. "It was the first sign of things to come," as author Stuart H. Holbrook remarked in "Holy Old Mackinaw," a sometimes lewd but acknowledged authentic history of timbering in the United States. Lumber men paid \$1.25 per acre for the land, buying it outright from the government. A dollar and a quarter an acre was the standard price of Michigan land, forested with trees like those at Hartwick Pines, for years, according to author Holbrook. Saginaw and Bay City were the sawmill towns, and they grew like Jack's bean stalk-big and rapidly. The Bancroft House Hotel was built in Saginaw in 1859. Lumbering for white pine was still going on over the Lower Peninsula, and the big lumber barons took only white pine, leaving all other trees for other far-sighted men who arrived here later. The above picture is a reprint from a very old copy of the Weidman Messenger, in the days when Rolla Roe was editor. This picture and short piece are our attempt at a sort of prologue to A History of Weidman which we hope to print now and then in the Messenger.

#### YOUR TAXPAYERS AT WORK

(Isabella County Taxpayers' Association )

Our neighbors to the north are organizing a Clare County Tax-payers' Association. The steering committee asked the Isabella Association to send members to their meeting recently. Attending were Mr. and Mrs. Gerald Cole, Mrs. Della Walker, Ron Ervin and Mr. and Mrs. Robert Spence.

The meeting was well attended. About 135 people were present, and they included a wonderful cross-section of people from all county sections, all walks of life. We wish them luck, and think they have a great deal of it going for them.

Three Clare County Commissioners attended. One kept alluding to "the experts from Isabella County". Della Walker finally told the Commissioner that we did not pretend to be experts, but had come as friends, by invitation, to be of any help we could. Mrs. Walker received spontaneous applause from the audience.

The Commissioner seemed genuinely upset that the "experts from Isabella" were there, and the reason why made for interesting discussion at the coffee hour following the meeting.

The problem in Clare County is a proposed zoning ordinance. The Commissioners are unable to explain certain parts of it, but they insist it has to be good, if not understood, because it was prepared by an expert. If price is any indication, it must be good: The expert cost \$26,000.

Our Association was formed primarily because we believed people had a right to question, receive correct information and to express opinions. We do feel that with this right goes the duty and responsibility of using correct facts, whether the user be an individual or an organization. We try to clarify facts that appear and might be misleading.

Let's keep in mind that the prosecuting attorney's position is a part-time job. If not, Mr.Fox could not have a private practice.

Let's understand that Mr. Fox does not contribute his private office, or private staff, to the county. For 1972 his department has a budget of around \$30,000. He is allowed fees for an assistant.

Any of the facts can be found by looking at the budget, or the monthly financial reports. If anyone has an opinion on whether this part-time position is under- or over-paid, it might be well to base the opinion on facts.

\*\*\*\*

Some other facts: The Automobile Club says 60 percent of the snowmobile deaths in Isabella County, so far this year, have

involved automobiles.

Rep. John Engler is sponsoring a bill to allow snowmobiles to operate on any county road. The bill would make any restrictions the responsibility (and expense, we assume) of county road commissions.

Conclusion: People should let Mr. Engler know how they feel about such a bill, either from the safety viewpoint or because of the use of county road funds for a purpose which is being passed by state determination.

\*\*\*\*\*\*

Another fact: Mr. Engler voted Yes on the governor's transportation package. The bill failed by six votes, but will be coming up again soon.

Originally this bill was to increase gasoline and diesel fuel tax by 1.3 cents per gallon, and included an increase in weight tax.

Then it was amended to two cents taxes on gasoline only. Evidently the often-mentioned "powerful highway lobby" isn't as powerful as some other lobbies—at least not in protecting the small out-state counties.

Whether Mr. Engler is aware of the amendments to this bill, or their implications, is not known. When questioned on the reason for his vote, he said this bill "is better than no bill because the counties need more money for roads."

The Association has been waiting for a copy of the bill with its amendments as voted upon, as well as any additional amendments.

At present the value to anyone but the metro area seems pretty well beclouded by amendments that seem to give, and others that take, and it is impossible to determine whether a county will get more or less than in the past. But it appears it could easily be less...in the out-state areas with small populations; the value to the metro area transit systems seems clear and stable.

This bill does not have to be passed this year. The little counties might be better getting along for one year without an increase in funds than to find themselves getting along for five or 10 years with only a token increase at best, possibly with a decrease in funds.

Each year the small out-state counties have an increase in road usage because of metro residents who vacation and use the out-state resorts. In addition the counties' own traffic increases.

The small out-state counties are not asking the metro area to subsidize our problems, but we aren't very anxious to solve metro's--and certainly not at the risk of making our own harder to solve because of lack of funds.

If you feel a hazy, hasty bill is

worse than no bill at all, you should inform Mr. Engler. And you might ask for a copy of the transportation bill and all amendments to date. (You can call 120-373-0834).

While you're in contact, don't forget to thank Mr. Engler if you are in favor of Senior Citizens over 72 not having to apply for their property tax exemption each year. Mr. Engler voted for this amendment, although it lost.

When there is more information, the Association will go into this bill more deeply, even if only to tell you what the small out-state counties will have to live with for the next five or ten years.

We mentioned the luck of Clare County in having so many interested citizens representing such a cross-section of professions. Clare also seems lucky to have a Representative in Lansing who remembers he is supposed to represent the interests of the small counties and have an understanding of their problems. Mr. Holbrook voted against the transportation package.

DOWNSTATE TOWNSHIP SUES STATE TAX COMMISSION

The Township of Cooper, in Kalamazoo County, has filed a suit against the Michigan State Tax Commission over a "factor" plastered on real estate proper-

The situation apparently parallels that of Coldwater Township in Isabella County, when Township Supervisor Lewis Bowen appealed to the State Tax Commission on behalf of the whole township after Gem Survey whizzed through.

For Coldwater Township, the State Tax Commission not only denied any hearing, but slapped a "factor" of 48 on Coldwater Township real estate, bringing taxes much higher than even Gem Survey had put them.
In a news letter to Township

Supervisors, the Michigan Township Association says that the Michigan State Supreme Court has ordered the State Tax Commission to hear complaints of Cooper Township.

The Supreme Court also indicated that it wants Cooper Township to return to the Supreme Court if it is not satisfied after the Tax Commission considers its complaints.

"This is a breakthrough of momentous import," the State Township Association said in its news letter. "It is an opportunity at long last for local units of government and individuals to be accorded the dignity of a full hearing before the Tax Commis-

The Michigan Township Association is asking contributions of \$10 from the personal money of all Township Supervisors to help Cooper Township carry through its legal procedure.

It is estimated that legal fees for that purpose will run about to \$50,000.

Anyone may contribute to the fund for Cooper Township's fight against the State Tax Commission. Contributors may send checks or money orders to Michigan Township Association Legal Defense Fund, 3121 West Saginaw, Lansing 48917.
